

Employment is found in a variety of roles within both the private and the government sectors. Government employers are Statistics Canada, Alberta Health Care, Social Services, ADAAC, Solicitor General, and the Royal Canadian Mounted Police. Dr. Jayachandran states that many students take an interest in Criminology where they can work in corrections as probation or parole officers. At present, given the aging population, there is a growing need for graduates in the area of Gerontology (aging) and Health Care.

If students are contemplating sociology as a major, Dr. Jayachandran urges them to talk to him about their desires, interests, and goals. The field of sociology contains various areas of

specialization and he wishes for students to get the proper guidance so that they do not spend unnecessary time in courses that are irrelevant to their aspired field. Because of Concordia's small student population the students have the invaluable opportunity to interact with their professors. on a one-on-one basis. Dr. Jayachandran will not only sit down with students to discuss their desires, interests, and goals, but he will also assess their strong areas and suggest some possible fields that are best suitable for them. Dr. Jayachandran states that a student with strong mathematic and statistic capabilities often excel in research analysis and work for agencies like Statistics Canada, whereas a student who prefers to deal with the public usually excels in areas like social work and corrections.


Undoubtedly, U of A has lots to offer, but there are certain advantages a student receives when he/she comes to Concordia. You be the judge.

LAUGH IF YOU MAY

My father liked to tell us stories about his alcoholic family who had no future, no hope-they just lived floor the next drink. Once, his youngest brother, Byron, was trying to cash a cheque at a store. The storekeeper had to call my dad to verify his brother's identity because Byron had no identification. She asked my dad to describe his brother. He replied, "well, he can look through a keyhole with both eyes. He's got short little bow legs, and he/s shaped like the Tasmanian Devil.." Needless to say, she cashed his cheque, and Byron continues partying.

Another time there was a commercial on the television which showed a cowboy walking into a Midas Muffler shop holding his pistols in an intimidating stance and shouted," I want to talk to Stringbean." Then Stringbean would walk out, terrified, only to find the cowboy had heard about his work and wanted him to fix his car. My dad's other brother, Harvey Joe, had walked into a Midas Muffler shop drunk. He shouted out to the mechanics, "I want to talk to

Stringbean." They didn't find this very funny and tossed him out laughing into the street.

Along with the laughter, we live everyday with Indian Statistics, statistics of Natives in jail, violent and sudden deaths, suicide and alcoholism. The statistics for violent, sudden deaths as opposed to natural deaths are 20%, versus 80%, in non-native communities. In native communities, these statistics are turned around.

I've learned from growing up native to find humour in everyday life, to laugh even when I could easily cry. When I worked as a Probation Officer on a reserve. I noticed that Native people don't seek counseling until it was court ordered or until they ended up in jail. Most of my clients never overcame the anger stage of grief, but they were some of the funniest people I have ever met. They had a lot of pain and they told a lot of jokes. I would get police reports with "bannock" on the list of stolen items!

My friends and I saw the movie "Dance Me Outside" recently. We found it hilarious because we could associate the fictional reserve setting in the movie with existing reserves.

The humour in the film was true to life rez humour. Some Native people did not like the movie, because they thought it was degrading. I think it's only degrading if we're ashamed of being an Indian from a reserve. The movie was a refreshing change from "Cowboys and Indians"; I get tired of always being the bad guy. I'm also tired of the New Native movies, because now we are always the goodguys-being-oppressed. We are made out to be very serious people with no human faults. "Dance Me Outside" could have been improved by having better actors, but I'd rather see bad Native acting than white people with painted faces pretending to be Native. After all, Graham Greene can only play so many roles!

Have you ever heard the saying "The only good Indian is a dead Indian." Well, that's not even true anymore. Now it's, "The only good dead Indian is one who dies a martyr to a cause." I watched a documentary of the Oka Crisis. Some parts almost brought me to tears. I could feel their pain. I could hear the trees, the people weeping over the injustice. The tears weren't brought on by sudden

anger; they were a result of over 280 years of declaring themselves sovereign and trying to protect what was left of their land. Out of frustration with the warriors, the army directed high pressure water hoses at the Mohawk encampment. The warriors used the water to fill up condoms which they threw back at the army. Before the food supply was cut off, the warriors checked the food being brought in by the army. The packages were punctured to check for weapons. One warrior said, "Look at this bacon." They're going to cholesterol us to death." With all the tension in the air and waiting for death, this warrior still managed to tell a joke.

From my father, I learned it is better to laugh with others and share my pain, rather than cry alone. Many Indian people face injustices and pain. I get comfort in knowing they have also learned to laugh. Humour has been powerful tool in the healing process of Native people, but it is often taken for granted.

There is speculation of a four year degree to start in 1997-1998 which would see an increase in the available courses and instructors. Furthermore, the anticipated four year degree would allow students to specialize further into their desired field. The program is also proposed to not only bring in potential employers to help design the program, but the students would actually be placed in a fieldrelated setting in their fourth year. Until that time, keep in mind that most sociology courses do transfer to other universities programs if seeking graduate work, and that there usually is no need to take a qualifying year (please confirm with the faculty and university of choice). Graduates from Concordia college have furthered

their academic studies at the University of Calgary receiving a Masters in Social Work (through the Faculty of Extension located in Edmonton) and the University of Alberta earning a Masters in Sociology.

If you are fascinated by social phenomenon, but you think there are no promising careers in sociology think again! There are numerous promising careers for individuals who are positive, enthusiastic, and motivated. Talk to Dr. Jayachandran (or "John" as he asks his students to call him) in office C3 (above the cafeteria) and your view will change!!

Dr. Jayachandran's background: Dr. John Jayachandran, Head of the Sociology Department has been instructing on a full-time basis for the past six years. His C.V. is diverse and

commendable. Dr. Jayachandran earned the following degrees and diplomas in India: BSc (Zoology), MSc (Anthropology), Diploma in Population studies, Dr. Jayachandran then came to the University of Alberta were he earned his PhD in Demography (population studies) while he was instructing in the sociology department for approximately six years. The Department is comprised on himself and Dr. Efa Etoroma on a full-time basis . Their different areas of expertise is complementary: the former in quantitative and Demography, the latter, in qualitative and Ethnic Relations. There are also five sessional in the department.



61% no



The Verdict




While the verdict was passed I could hear the shouts of what seemed like joy as O.J. Simpson was found not guilty. THINK, if O.J. didn't commit the murders of Nicole Simpson and Ron Goldman, who did? Who cares, for those on the defense team it wasn't about murder but a battle ground for the racial bias in the American Justice System. This trial placed American justice on the stand and came up wtih a corpse.

Right from the jury selection when defense and prosecution lawyers started picking apart jurors along racial lines we knew it was going to be a big race battle. Defense team lawyers found their cloak to caste shadows within Mark Fuhrman. After that, all that was needed was a mention of planting evidence and reasonable

doubt is shown. Because, in L.A. it is a popular belief that all cops like to do is beat defenseless black motorists. Mark Fuhrman was not a very good witness. Defense lawyers exploited this and showed Fuhrman as the embodiment of the American Justice System, in which no black could get a fair trial. Only when cops like Mark Fuhrman are off the force will justice be blind.

The American Justice System will have difficulty bringing justice where racism exists. Black Americans don't need a fallen role model like O.J. Simpson. They got what they wanted, a trial with media attention and a victory for the cause. The cost was the forgotten death of Nicole Brown Simpson and Ron Goldman.

REV. JOHNSON OF THE MAKAH TRIBE TO SPEAK AT CONCORDIA

The Rev. Don Johnson, Executive Director of the Lutheran Association of Missionaries and Pilots (LAMP) will be the guest speaker at the Church Workers' Association meeting on Monday, November 6, 1995 at 5:45 p.m. in the Conference Room in Guild Hall. Everyone is welcome to attend.

Pastor Johnson is a Native American of the Makah Indian Tribe of the Pacific Northwest and was elected to serve on the Tribal Council from 1982-1992, five of those years as chairman. In 1973, following graduation from Concordia Seminary, Springfield, Illinois, he established the Makah Lutheran Church and served as pastor from 1974-1993. He is presently working toward the completion of a Doctor of Ministry degree from Luther Northwest in St.

Paul, Minnesota.

One of Pastor Johnson's hopes is to raise awareness within the Lutheran community of the factors that have caused Native Americans to become more dependent upon the dominant society than they were before the coming of Columbus and more dependent than they wish to be. Coupled with this is the need to inform the Lutheran community of the desire of Native Americans to become interdependent as a Christian community without losing their cultural identity.

As Executive Director of LAMP, Pastor Johnson is responsible for the organization in the US and Canada. LAMP consists of full-time pastor pilots as well as volunteers who work in the far north with many Native communities. The Canadian LAMP office is located here, in Edmonton.





TO LOSE OR NOT TO LOSE - THAT IS THE QUESTION

By the time you graduate you will have hopefully mastered the art of a new game. The game is not a physical sport, but a skill in mastering the educational system - I officially welcome you to the game of academics. You may have already experienced the frustration of not knowing the rules to this pseudo-game. In university and college there is no one watching everyone's academic moves. Instead the rules are located in the school calendar and it is up to the student to seek them out. Sometimes concerns or questions are not directly answered in the calendar. In that case, it is then necessary for the student to seek answers, clarification, and confirmation elsewhere. This entails running around to various offices and/or campuses - talking to advisors and faculties which can be, at times, totally confusing! Any recommendations or suggestions that were stated during your jog around campus and town (which are not directly indicated in the calendar) should be placed in writing for your own protection.

Recently I was told of a student at another institution who, while working both towards the completion of an undergraduate degree and entrance into the Faculty of Physiotherapy, was being counselled by an academic advisor. She graduate with honours from her the undergraduate program, but she was not accepted into physiotherapy because she did not have ANY prerequisites. The counsellor is supposed to be an expert; however,

experts can make mistakes. Unfortunately, it was at the student's expense who only sought, accepted, and relied upon the advise of the counsellor. That is why when students are dealing with something that is as impor-

tant as education, it is up to the individuals to be proactive and confirm information that is given to them with the university calendar and with the aspiring faculty. Any education one receives is valuable, however, four years of studying something irrelevant to what a students wants to get into, exhausts not only one's time but financial resources. Getting to know the policies and procedures of your school is fundamental so that you will not experience future frustration, disappointments, or disenchantment with education. This is a very unu-

sual and most unfortunate incident - that is why precautionary steps should be taken by students to facilitate a smooth transition into aspiring faculties. More often I hear of students who are stumped by ambiguous or contradictory rules of various institutions. After talking with Assistant Registrar Kathryn Luedtke, it seems that some students do not realize that the depiction of the course marks on their transcripts is different in high school than it is in university/college. In high school, if a student takes a



course twice, the first grade will be dropped from the transcript. This is not the case in post-secondary education. Initial course marks remain on the transcript even if students take the course a second time. In addition, to make it even more frustrating and confusing for students, each university/college differs in their policy on how many times a course can be attempted. The Registrar's Office at the University of Alberta stated that students should talk to the faculty that

they want to transfer to because in some faculties a course can only be attempted twice (that is, only allowed to drop a course one time). The second time a course is attempted, the mark is still placed on the transcript - even if it is a '1'. This is extremely important if students wish to gain entrance into faculties with high GPA requirements (ie: medicine, law, and physiotherapy).

In this respect, it is most important that students look at the calendar and determine which courses are required. Once enroled in a course students should check the syllabus and assess their feelings and thoughts towards not only the curriculum, but the ideologies of the professor. It is better to withdraw from the course rather to struggle through the entire semester and obtain a low grade in the

course. The deadlines for withdrawals are depicted in the college calendar. The first deadline for dropping the course, or transferring to another course without receiving a 'W' on the transcript, is usually within the first week of each semester. The second

deadline, for withdrawal (in addition to change from credit to audit) is November 10th, 1995. That is, after the first deadline date and before November 10th a 'W' will appear on the student's transcript indicating that the student has withdrawn from the course. However, after this date, if the student withdrawals from the course a 'WF' appears on the transcript which is equivalent to a grade of '1.'

After students have researched through Concordia's calendar or the various university/college calendars (the library has many provincial, national, and international post-secondary calendars available to students) and they still have questions or concerns, the staff at Concordia is here to minimize the stress and anxiety that students may be experience in meeting certain pre-requisites, co-requisites, distribution requirements, and the like. In mid-November there will be an information session to help you plan for the up-coming academic year (TBA). Until that time, students can go to the Registrar's office and talk with either Kathryn Leudtke or Janet Kraemer regarding any concerns or questions they may have and pick up a program planner guide. As Luedtke states, "We are here for the students . .. to help them."

It is here, leafing through various calendars, running around talking to various department members and various aspiring faculties, that students learn the pseudo-game in higher-education - its called frustration!

MACBETH: ON STAGE, UP FRONT

Macbeth, for anyone who is familiar with this romantic tragedy, conjures up images of blood spilling forth. On stage, witches and apparitions appear with knowledge of the future in their chilling chants. The play is set during medieval times of swords and sorcery. Distinguished regal Kings and Queens struggle for diving power, going mad in their quest.

The story of Macbeth was first written by historian Raphael Holinshed, and dramatized in 1606 by William Shakespeare. Some eight hundred years after the original events took place, Director Jonathan Christenson gave UCEP students and the rest of Edmonton his 1995 adapted version of Shakespeare's Macbeth.

On the Timms stage there were no crowns studded with sparkling diamonds or emeralds. The long flowing gowns and robes, the colour of royalty, were absent as well; there are no shining suits of armor clad in chain mail. Instead, the performers wear modern day attire and rather than leather slippers on their feet they wore Doc Martens.

I had the opportunity to acquaint myself with the Tragedy of Macbeth before seeing the performance live. If not for this opportunity I would have been at a complete loss. The manner of speech took awhile to get accustomed, as well I found it difficult to distinguish between the Lords and

the Generals. The military ranking was not as visible as one might think it should be.

The stage was basic. A large quilt hung on the back wall, representing the sleep that Macbeth forfeited when he killed the King. In front of that, off to the side were wooden frames set on a downward angle. The stage floor was a metal grate which gave the scene an almost futuristic, ultra-modern look and sound. Not a curtain

was lowered or raised; the stage props were carried in and out by the performers purposely as a part of the performance. As well, the cadavers were taken off the stage by the witches as if they were taking the souls of the dead. It was a creative and tactful way of disposing of the bodies. It would have taken away from the performance if the slain had risen and just walked off the stage on their

From the dimming of the lights to the first beat of a drum, I was captured. I felt as though I was indeed in the very presence of royalty, as I watched Macbeth and Lady Macbeth walk proudly, yet somewhat arrogant-

ly to the front of the stage.

I admire the performers for finding it within themselves to get up on a stage and perform for a live audience. Lady Macbeth was eminent in her performance, I found myself watching her every move. I could see her going insane from the blood in her hands. Seyton, the cutthroat villain, was a character in himself, an uncanny candor about him that was different from the other performers.

Just before Banqus was assassinated, he says to his son Fleance, "It looks like it's going to rain". At that instance Seyton enters, slaps his thigh twice, rocks back and forth on his heels and says "Let it rain then" in a matter of fact tone of voice. Then without hesitation, he murders Banqus.

Jonathan Christenson literally gives Macbeth a new look. Yet the theme of Macbeth remains the same; it is timeless and universal. The struggle for ultimate power and the lengths that men and women will go to to obtain such power is an abhorrent side of human behaviour.

We have seen this drama performed eight hundred years after the events took place, through the imagination of Jonathan Christenson who conveyed to us the underlying theme of how power corrupts good people.

In the year 2795, eight hundred years from now, will this tragic story still be around or will it be shelved? Or an even more disturbing question: Is there another tyrant coming?

QUIET PAIN

(Initially the reaction was not to run this article. When the matter was brought up to the staff, I was shocked to hear that many of the female staff were not aware of the existence of this mutilation that goes on in certain cultures. Women and men must know the facts and rise up in an effort to end this practice. The Editor)

Female circumcision is a process that results in the mutilation of the female genitalia. Young girls, usually between the ages of three to eight, are subjected to one of three types of mutilation based on their local tradition.

The 'milder', less used form, called circumcision (or sunna) involves the removal of the tip of the clitoris. The more widely used clitoridectomy is the excision of the entire clitoris and the adjacent parts of the labia minora. The third more sever

form is referred to as infibulation which is the removal of the entire clitoris, the labia minora and labia majora, plus the joining of the scraped sides of the vuvla across the vagina, where

they are secured with thorns or sewn with thread. A small opening is preserved by inserting a sliver of wood into the wound during the healing process, thus allowing passage for urine and menstrual blood. An infibulated woman must be cut open to permit intercourse and cut further to permit childbirth, after which, she is then resown.

This surgery is usually experienced in less than hygienic conditions with little or no anesthesia, with the aid of six to eight people (usually

women), holding the little girl down. According to the magazine, *The New International*, 1993 World Health Organization figures estimated that

"90 million girls and women alive today have endured one or the other procedure, and that two million more girls do each year." Girls are subjected to this traditional mutilation simply to increase their prospects for marriagibility. Either procedure is to ensure

the wife's fidelity to her husband. What most girls are left with is, a combination or one of, a future of painful menstruation, urine infections, fear of death during childbirth, and painful

As stated in The Geographical Magazine, female circumcision is still prac-

ticed by Muslims, Catholics and Protestants in Africa, United Arab Emirates, Indonesia and Malaysia. *Health-*

sharing has reported that it is prevalent in India, Pakistan and involves newcomers to Australia, Europe and North America, which includes Canada. In 1986, Britain saw the need to make female circumcision illegal, however, evidence shows that the practice continues.

Article 5 in The United Nations Universal Declaration of Human Rights states that "No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment." Female Genital Mutilation should be eradicated and all practices that exist under the guise of 'culture'. There is no rationalization for torture.
