The T2202A is your official tax receipt used to claim the eligible educational expenses for the tax year on your income tax return. The form includes the amount of tuition that can be claimed as well as the number of months eligible for the education deduction.

## CHANGES TO CAFETERIA SERVICE

Effective May 1, 2014 Aramark Canada Ltd. will become Concordia's food services provider.

Choices Catering, who has been our caterer since August 2010, and we wish them well as they leave Concordia.

There will be no disruption of catering service, as Choices will be on site until April 30, but providing reduced service over lunch time. They will also provide services to you if you need food for an event.

The new caterer will be ready to provide service starting May 1, but will limit operations to the kiosk on the main floor of Tegler for a few days, until they are set up in the cafeteria. They will have a selection of sandwiches, wraps, parfaits, soup, chili, fresh [pastries, Starbucks coffee, cold beverages, breakfast sandwiches, and weekly barbeque available in the kiosk.
