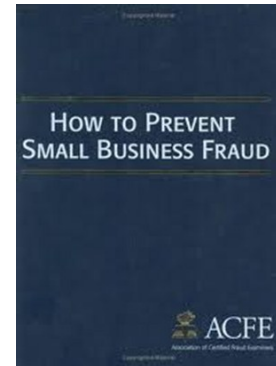

MGT430- SPECIAL TOPIC FRAUD EXAMINATION: THEORIES AND METHODS

SCHEDULED TO BE OFFERED IN FALL 2012



This course will cover the principles and methodology of fraud detection and deterrence; an integral component to effective corporate compliance. The course includes such topics as: fraud theories, skimming, cash larceny, check tampering, register disbursement schemes, billing schemes, payroll and expense reimbursement schemes, non-cash misappropriations, corruption, accounting principles and fraud, fraudulent financial statements, and interviewing witnesses.

Upon completion of this course, a business student should have the ability to:

- a.** Appraise the reasons, motivations and rationalizations behind individuals and organizations committing acts of fraud;
- b.** The ability to recognize and analyze various consumer, organizational and computer based fraud schemes; Detect various financial statements fraud exposures;
- c.** Formulate and implement an effective fraud investigation process to accumulate court admissible evidence and to effectively communicate the findings of such investigation in a criminal or civil trial;
- d.** Construct the various steps and methodologies for detecting, analyzing and investigating incidents of consumer or organizational fraud;
- e.** Recommend and Design control processes to help reduce incidents of organizational fraud;



Starting in Fall 2012

Master in Information Systems Assurance Mgt.

This program will be offered as a degree or graduate certificate. Program pre-requisites include a four year college degree, previous courses in financial and managerial accounting, a minimum admission GPA of 3.0 and a security clearance. Students in the program will also be encouraged and mentored to seek professional certifications as a Certified Internal Auditor (CIA), Certified Info. System Auditor (CISA), and Certified Info. Systems Security Professional (CISSP).
